Authors submitting a manuscript to CAR must take joint responsibility for the content of the paper, including all wording, methods, data and results. CAR encourages broad sharing of research data and tools after publication, to aid replication and to encourage future research.

- If the paper has more than one author, we delegate responsibility for correspondence with CAR, including this declaration of responsibility, to a single member of the author team.
- I (we) understand that after the initial submission, changes to authorship (additions, deletions or changes in order) must be agreed by all authors in writing and approved by the Editor-in-Chief
- I (we) conducted the research in an ethical manner, including obtaining any necessary institutional ethics clearance for research involving human participants. I (we) have disclosed that fact in the paper. If I (we) have not obtained such clearance because I (we each) work at an institution that does not have a review board to provide ethics clearance for research involving human participants, I (we) have disclosed that fact in the paper.
