## CAAA 2025 Call for Papers: Accounting and Accountability in a Disruptive Marketplace

In today's rapidly changing global landscape, characterized by technological innovations, economic shifts, and socio-political turmoil, the roles of accounting and accountability are more critical than ever. The 2025 CAAA Conference, under the theme "Accounting and Accountability in a Disruptive Marketplace," invites scholars, practitioners, and policymakers to explore these roles within the context of a market increasingly influenced by digital and platform disruptions.

Drawing on Karl Polanyi's notion of the Market Society, this conference seeks to delve into the embedded nature of economic activities, within societal contexts. Polanyi's seminal work articulates the dangers of a disembedded market, which attempts to function autonomously from societal and environmental constraints, leading to profound social dislocations and ecological crises. This theoretical backdrop is crucial for understanding how accounting and accountability can counteract the destabilizing effects of market autonomy in safeguarding human and environmental values.

We will examine the influence of platform organizations as highlighted by Agyei-Boapeah et al. (2022), and the technological advancements in information and communication technologies as discussed by Kornberger et al. (2017). These elements have changed the nature of work, economic transformation, and wealth distribution, presenting unique accountability challenges and opportunities for the accounting profession.

Key questions the conference will address include, but are not limited to the following:

- How do accounting practices adapt to and resolve the tension between market forces and societal values?
- In what ways do accounting and accountability serve as mechanisms to align business practices with broader governance, social, and environmental responsibilities in a disruptive economic climate?
- How can accountants lead in value creation and innovation, and maintain ethical integrity in a rapidly evolving business landscape?
- How can accountants contribute to public sector accountability in a convoluted economy?
- How can accounting professionals promote equity, diversity, inclusion and Indigenization in a turbulent world?
