CAAA Annual Conference 2025

• We continue to organize the Education Program for the CAAA Annual Conference.

• The CAAA adopted a new submission and program platform this year, X-CD, which we used to manage the Education program as well.

- We received **20 education proposals** for this year's program: 19 in English and 1 Bilingual.
- This year, we made the decision not to run education sessions concurrently with CPA Canada sessions. After the conference, we will review the results of this change.
- All formal communications with submitters have been bilingual.

• One of our members, Sanobar Siddiqui, proposed a webinar connected to her recently published article in *Accounting Perspectives*. This webinar will take place on **May 2, 2025**. Conference Planning and Scheduling

Following the January 31 submission deadline, we initiated preparations for the paper review and scheduling process. The Scientific Committee has completed all reviews, and authors were notified of the acceptance decisions in early April. Authors were also asked to confirm their attendance and presenting author information by April 15. The co-chairs are now in the process of constructing the preliminary schedule.

We currently have 176 accepted research papers and a capacity for 180 presentation slots. We have accommodated several special scheduling requests (e.g., preferred presentation days) and encouraged authors to update their titles and abstracts for the final program. To manage the program effectively, we have limited each author to a maximum of two presentations. Discussants will be assigned and notified in the coming weeks.

We received several requests for visa support and carefully evaluated each on a case-by-case basis, recognizing that some individuals might seek to use the opportunity for purposes beyond conference participation. Accordingly, we approved support letters exclusively for authors with accepted papers.

Plenary Speakers and Conference Program

We are pleased to confirm the participation of our plenary speakers: Professors Lee Parker and Partha Mohanram (*Accounting and Accountability in a Disruptive Marketplace*), and Professors Marcia Annisette and Marion Brivot (*How Accounting Academics and Practitioners Can Promote EDI in the Workplace & Society*). We have communicated with each speaker regarding session logistics and are working to finalize room assignments and supporting technology. A detailed planning document for plenary sessions is currently under development. We also requested that the Executive Director, Carina, notify Pamela Steer of CPA Canada, regarding the logistics for her session.

Craft of Accounting Workshop

Professor Partha Mohanram has engaged several faculty members to assist in organizing the Craft of Accounting Workshop. PhD students will benefit from free registration for this year's conference. Panelists confirmed for the workshop are Professor Anup Srivastava (University of Calgary), Professor Michel

Magnan (Concordia University), Professor Abu S. Rahaman (York University), and Dr. Minlei Ye (University of Toronto).

Talent Show at Gala Dinner

The Talent Show lineup is confirmed, featuring eight diverse performances, including music, dance, and piano. Coordination of performances and equipment requirements will be finalized in May.

Volunteer Recruitment and Coordination

We are recruiting a group of student volunteers from Toronto Metropolitan University to assist with on-site logistics, registration desk duties, and session management. Light refreshments and meals will be provided for the student volunteers by CAAA. Student involvement is also supported with \$2,000 in funding from the Accounting Department of TMU, approved by Dr. Shadi Farshadfar (Accounting Chair). Additionally, Dr. Oliver Okafor has secured a \$1,000 TRSM Matching Funds Grant, bringing total financial support for student volunteers to \$3,000.

External Relations and Institutional Engagement

The CPA Ontario has requested for involvement in the conference. One option we considered is hosting a Thursday evening reception at CPA Ontario's new downtown Toronto office. Another possibility is inviting CPA Ontario to host a closing event on Saturday evening, which could enhance attendance for Saturday research presentations. In recognition of the complicated relationship between CPA Ontario and CPA Canada, we relayed the CPA Ontario's request to the Executive Committee for guidance. We are awaiting further engagement by the CAAA Executive Committee with CPA Ontario to address their request, while ensuring continued compliance with CAAA's contractual obligations to CPA Canada.

Conference Menu

We have been collaborating with both TRSM's internal event vendor and the Marriott to finalize the conference menu. Several meetings have taken place to coordinate catering options and ensure a high-quality culinary experience for all attendees.

At the end of December 31, 2024, the CAAA membership reached 804 members, a record in the history of the organization. While the CAAA membership runs a calendar year, traditionally the membership drive begins in November of each year. At the end of October 2024, as the organization was preparing

to open the renewals for 2025, the service provider of the CAAA registration system indicated it was no longer able to support the CAAA. As a result, membership renewals for 2025 were delayed by three months, while a new system was developed. Because the 2025 renewals did not begin until later in January, to provide meaningful comparatives, this report reflects March 31, 2025 numbers along with January 31 numbers of prior years. As a result, all reported periods reflect a three-month period of membership renewals.

As of March 31, 2025, our organization was comprised of 368 members. This is a decrease of 84 members from March, 2024, producing a 19% decrease in renewals over a three-month renewal period. We are working to generate more renewals in the current year. The demographics of our membership are similar to last year, with 60% members working in Canada, 16% in the U.S., and 24% in other countries. Our membership continues to span 24 countries and 180 institutions this year. The universities with the most members were: U. of Waterloo (16 members), U. of Toronto (10 members), Wilfrid Laurier U. (8 members), Concordia U. (9 members).

College memberships are at 10%, while universities make up the remainder 90%. Therefore, membership from education focused institutions increased 5%, in line with the new discounted memberships for educators. In line with the CAAA DEI initiatives, the CAAA is also offering complimentary memberships to Indigenous academics at post-secondary institutions in Canada, as we continue to explore ways to diversify the membership and build a strong, welcoming community. We continue to work to generate new memberships and provide value to our current members which now includes a webinar professional development series which provides members with verifiable PD hours.

Bilingualism

This year we continued our efforts at identifying ways to be more inclusive of francophones. A team composed of Caroline Blais, Charles Cho, and Kim Trottier held two Town Hall meetings in February 2025 to solicit input on how best to engage francophones. Combining this information with findings from the francophone panel at last year's CAAA conference, our next steps are to prepare a synopsis of (1) issues identified (2) improvements made to date, and (3) further improvements needed. This will feed into the CAAA strategic review exercise in the Fall of 2025. After the strategic review, a full report will be released in November 2025 with an action plan that we hope will encourage more francophones to join us.
